**Official Rules**

- 1. SWEEPSTAKES PERIOD:** The Sweet Summer Furniture Giveaway Sweepstakes (the “Sweepstakes”) will begin at 12:00 a.m. E.T. on Monday, July 10, 2023 and end at 11:59 p.m. E.T. on Monday, July 31, 2023 (“Sweepstakes Period”).
