Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS, RULES AND REGULATIONS APPLY. ODDS OF WINNING DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES TIMELY RECEIVED. VOID WHERE PROHIBITED.

1. SWEEPSTAKES PERIOD: The Canvas Chronicles T-shirt Kids Coloring Contest at Melody Farms Sweepstakes (the “Sweepstakes”) will begin at 12:01 a.m. C.T. on Sunday, September 10, 2023, and end at 11:59 p.m. C.T. on Sunday, September 17, 2023 (“Sweepstakes Period”).

There will be one winner per age category:

Category One - Ages 5 & under

Category Two - Ages 6 -12 years

Category Three - Ages 13 years & Up

Uploads may not defame or invade the rights or privacy of any person, living or deceased, or otherwise infringe upon any third party’s personal, proprietary, or intellectual rights; may not contain illegal or unlawful material; may not promote bigotry, racism, harm, or discrimination; and must be consistent with Sponsor’s reputation in the marketplace and be suitable for audiences of all ages. Uploads which, in Sponsor’s sole discretion, violate these conditions or which contain any type of vulgarity or objectionable content will be disqualified.

By uploading a photo, you accept and agree to abide by these Official Rules. Sponsor is not responsible for late, illegible, corrupted, or misdirected entries. Entries generated by script, macro, robotic, programmed, or any other automated means are prohibited and will be

disqualified.
